

KARNATAKA STATE ADMINISTRATIVE TRIBUNAL AT BENGALURU.**No.KSAT/RPS/NOTFN/BLGV-BENCH/30/2018 Date:10.12.2018****NOTIFICATION**

Sub: Commencement of KSAT Bench at Belagavi and issuance of Notification under Section 5(6) of Administrative Tribunals Act, 1985-Reg.

The Government of Karnataka by Notification bearing No.DPAR.15.SAT.2015 dated 13.8.2015, in exercise of the powers conferred by sub-sections (1) and (8) of Section 5 of the Administrative Tribunals Act, 1985 (Act 13 of 1985) ("**AT Act**") has established the Bench of Karnataka State Administrative Tribunal ("**KSAT**") at Belagavi. Further, the Government of Karnataka in exercise of the powers conferred by sub-section (1) of Section 18 of the AT Act has directed that all cases arising from the districts of Belagavi, Bagalkot, Bellary, Dharwad, Gadag, Haveri, Koppal and Uttara Kannada-Karwar will be heard and decided at the Belagavi Bench and with regard to transfer of pending cases pertaining to the above mentioned Districts and filing of new cases at the Belagavi Bench the same will be notified later. Accordingly, the KSAT issues the following Notification under Section 5(6) of Administrative Tribunals Act, 1985:

2. The Hon'ble Chief Minister of Karnataka State has consented for inauguration of Bench of KSAT at Belagavi on 17.12.2018 at 10.00 AM.

3. In view of the inauguration of the Bench of KSAT at Belagavi on 17.12.2018, in exercise of the powers conferred under sub-section(6) of Section 5 of the AT Act, the Hon'ble Chairman of KSAT would function as Bench consisting of Single Member at Belagavi Bench on 17.12.2018 and take up the matters that will be listed for hearing and the same will be notified in due course.

4. From 17.12.2018 onwards and until regular sitting is provided at Belagavi, cases arising out of the above said Districts including Original Applications, Contempt of Tribunal Applications, Review Applications and Miscellaneous Applications, etc. are permitted to be filed either in the Belagavi Bench or in the Principal Bench at Bengaluru.

5. Further, all pending and future cases arising out of the above said Districts will be taken up by the Principal Bench of KSAT according to the existing roster, until further orders.

6. If any urgent order is required in the cases filed in the Registry at Belagavi, such matter may be moved before the Hon'ble Chairman for posting of the case for hearing.

7. Applications, Contempt of Tribunal Applications ("CTAs"), Review Applications, Miscellaneous Applications filed under Section 19, 17, 22(3)(f) and 22(3)(h) of the AT Act and Caveat Petitions filed under Karnataka Administrative Tribunal (Caveat) Regulation (1 of 1987), respectively, before the Belagavi Bench shall be numbered as under:
