Whereas by Notification dated 22.07.2020 referred to at (1) above, Division Bench comprising of **Sri T.Narayana Swamy**, **Hon'ble Judicial Member**, sitting at Belagavi Bench and **Sri N.Sivasailam**, **Hon'ble Administrative Member**, sitting in his Chambers at Principal Bench, Bengaluru, was constituted to hear cases through Video Conference **from 03.08.2020** at **3.00 P.M.**, which was later notified as **2.30 P.M.**, and till today, hearing of cases through Video Conference, went on smoothly.

Whereas in the Note dated 22.09.2020 referred to at (2), the Deputy Registrar, Belagavi Bench, Belagavi, has intimated that on 22.09.2020 at about 2.30 P.M., when the Hon'ble Judicial Member was entering Court Hall at Belagavi Bench, certain Advocates carrying placard started shouting slogans and obstructed the Court Proceedings till 2.45 P.M., and demanded for stalling Court Proceedings through Video Conference. As a result, the Division Bench sitting through Video Conferencing could not be continued.

Therefore, in exercise of the powers conferred under Section 5 of the Administrative Tribunals Act, 1985 and all other powers enabling thereunto, the Division Bench of **Sri T.Narayana Swamy**, **Hon'ble Judicial Member**, (sitting at Belagavi Bench) and **Sri N.Sivasailam**, **Hon'ble Administrative Member**, (sitting in his Chambers at Principal Bench, Bengaluru), through Video Conference at **KSAT**, **Belagavi Bench**, is cancelled **w.e.f. 23.09.2020**.

In view of the above unfortunate incident, with effect from 23.09.2020, fresh Applications pertaining to Belagavi Bench are permitted to be filed before the Principal Bench and such Applications will be posted before Court Hall-II of Principal Bench.

In so far as pending Applications pertaining to Belagavi Bench, where urgent orders are sought, they are permitted to be moved before the Registrar of Principal Bench and such Applications will be posted before **Court Hall-II** of Principal Bench.
