The Govt. of Karnataka in its Order bearing No.RD 158 TNR 2020 dated **07.05.2021** and Circular dated **10.05.2021**, in continuation of the earlier Order dated **26.04.2021** has issued further guidelines for stringent containment measures to break the chain of Covid-19 [Second wave] Transmission in the State, w.e.f., **10.05.2021 to 24.05.2021** (bdi) and ordered that only **50%** of the staff shall work on rotation basis during the above period.

In view of Government Order/Guidelines, the Hon'ble High Court of Karnataka, has ordered in its Notification dated **04.05.2021** and **10.05.2021** to combat the surge of **COVID-19 Positive Cases**, directing the District Courts and Trial Courts to take-up only the emergent/urgent matters for hearing through video conference only.

Therefore, in order to contain the transmission of **COVID-19 Positive Cases** in the KSAT premises, the Karnataka State Administrative Tribunal, Principal Bench, Bengaluru and benches at Belagavi and Kalaburagi, will take up only urgent matters w.e.f., **17.05.2021 to 22.05.2021** and matters will be posted before the benches by restricting the number of cases [**including fresh and urgent matters**] strictly by **virtual hearing**, during the above said period.
