**Sub:** Commencement of KSAT Bench at Kalaburagi and issuance of Notification under Section 5(6) of Administrative Tribunal Act, 1985 – Reg.

The Government of Karnataka by Notification bearing No.DPAR 33 SAT 2015 dated 13.8.2015, in exercise of the powers conferred by sub-sections (1) and (8) of Section 5 of the Administrative Tribunals Act, 1985 (Act 13 of 1985) ("**AT Act**") has established the Bench of Karnataka State Administrative Tribunal ("**KSAT**") at Kalaburagi. Further, the Government of Karnataka in exercise of the powers conferred by sub-section (1) of Section 18 of the AT Act has directed that all cases arising from the Districts of Bidar, Bijapur, Kalaburagi, Raichur and Yadagiri will be heard and decided at the Kalaburagi Bench.

2. The Hon'ble Chief Minister of Karnataka State has consented for inauguration of Bench of KSAT at Kalaburagi on **17.09.2019 at 1.00 PM.**

3. All pending cases relating to Kalaburagi Bench excluding Part Heard matters, reserved for orders matters, cases relating to Transfer of Excess Teachers and the cases mentioned at Sl.Nos. (i) to (v) of the Notification dated 03.04.2019 under reference shall be transferred from Principal Bench, Bengaluru to Kalaburagi Bench, w.e.f. 17.09.2019.

4. All future cases including Transfer of Excess Teachers pertaining to the above mentioned Districts shall be filed before Kalaburagi Bench w.e.f. 17.09.2019.

All future Applications, Contempt of Tribunal Applications ("CTAs"), Review Applications and Miscellaneous Applications filed under Section 19, 17, 22(3)(f) and 22(3)(h) of the AT Act and Caveat Petitions filed under Karnataka Administrative Tribunal (Caveat) Regulation (1 of 1987), respectively, before the Kalaburagi Bench shall be numbered as under:



6. All Contempt Applications arising out of five Districts shall be taken up by the Single Member Bench of KSAT, Kalaburagi, till the stage of hearing and framing of charges until further orders.

7. The Calendar of Principal Bench of KSAT for the year 2019 will be applicable to KSAT Bench, Kalaburagi.

8. The Office of KSAT Bench at Kalaburagi shall function on all working days from 17.09.2019 onwards and will work half-a-day on all working Saturdays.
