- 12) Sworn IA for CA needs to be filed.
- 13) Advocate's Address for service is not mentioned in the causetitle.
- 14) Advocate's Mobile No / E. Mail ID needs to be mentioned in the Address for service.
- 15) Provision of Law mentioned for the application is incorrect.
- 16) Provision of law for the application needs to be mentioned.
- 17) Address for Respondents / R-1, R-2, R-3, R-4, R-5 ---- etc. is / are incorrect.
- 18) Address for Respondents / R-1, R-2, R-3, R-4, R-5 ---- etc. is / are Incomplete.
- 19) Respondent/s Designation / Department / Pin Code No. not mentioned.

- 20) Private Respondent/s Residential Address needs to be mentioned.
- 21) Order No. / Respondent No. who passed the Order / Date / Subject is not mentioned in para 1.
- 22) Limitation para needs to be elaborated.
- 23) Provision of law needs to be mentioned in limitation para.
- 24) IA for CD is not filed as stated in the limitation para.
- 25) The application is barred by limitation.
- 26) Number of days of delay needs to be mentioned in IA for CD.
- 27) Sworn IA for CD needs to be filed.
