Whereas, Intimation Letters dated: 10.03.2023 were issued to 334 candidates (323 under RPC and 11 under LC) who have submitted their applications in order and the same were accepted by the Selection Committee, to appear for Verification of Original Documents held from 27.03.2023 to 29.03.2023. Out of 334 candidates, 288 candidates (280 under RPC and 8 under LC) attended the Verification Process and 46 candidates (43 under RPC and 3 under LC) remained absent.

Whereas, after verification of original documents, the selection committee in its meeting held on 10.04.2023, recommended the names of the following candidates for further selection process to the post of Stenographers in KSAT on the merit basis.

Whereas, the list of candidates recommended by the Selection Committee and the Merit list of the candidates under RPC and LC Quota was published in the Official Website of KSAT on 10.04.2023.

Whereas, the Call Letters were issued to 8 candidates recommended by the Committee to appear on 24.04.2023 before the Hon'ble Chairman cum Appointing Authority, KSAT, Bengaluru for test which includes taking dictation by shorthand and typing the same in computer. Only 6 candidates under RPC and 1 candidate under LC Quota appeared before the Hon'ble Appointing Authority and one candidate under SC(O) Category namely Kum.Varshitha.R., remained absent. The candidate Kum.Varshitha.R., was given one more opportunity to appear before the Hon'ble Chairman on 03.05.2023, but the candidate failed to appear on the second opportunity too. As such, it was decided to issue call letter to the next meritorious candidate in the said category and accordingly, Smt.Tara.B.M., was called for test on 23.05.2023 who appeared on the said date.

Whereas, on conducting the test/interview, the Hon'ble Chairman cum Appointing Authority has declared all the 8 candidates are eligible and suitable to be appointed as Stenographers.

Wherefore, it is notified for the information of General Public, that the following candidates are selected provisionally for appointment to the posts of Stenographers in Karnataka State Administrative Tribunal, in the order of merit mentioned below, under Residual Parent Cadre Quota/Local Cadre Quota.
